

The Canada Infrastructure Bank (CIB) is an impact investor developing the next generation of infrastructure Canadians need. #### Manitoba Fibre

*Digital Infrastructure and AI / Manitoba*

The Manitoba Fibre project now is complete with more than 2,657 km of fibre-optic cabling deployed across Manitoba. Our \$164M loan in partnership with Valley Fiber Limited and DIF Capital brings high speed internet access to more than 53,000 households in underserved regions, enabling access to remote education and health care.

#### Port Stalashen Wastewater Treatment Plant

*Enabling Housing Supply, Indigenous Infrastructure / shíshálh Nation, Sechelt, British Columbia*

The Indigenous-owned and operated Port Stalashen Wastewater Treatment facility in Sechelt, BC, is complete. Our \$6.4M loan in partnership with the shíshálh Nation Government District was critical to helping the community replace aging infrastructure, increase wastewater treatment capacity and provide economic and environmental benefits to the Nation.

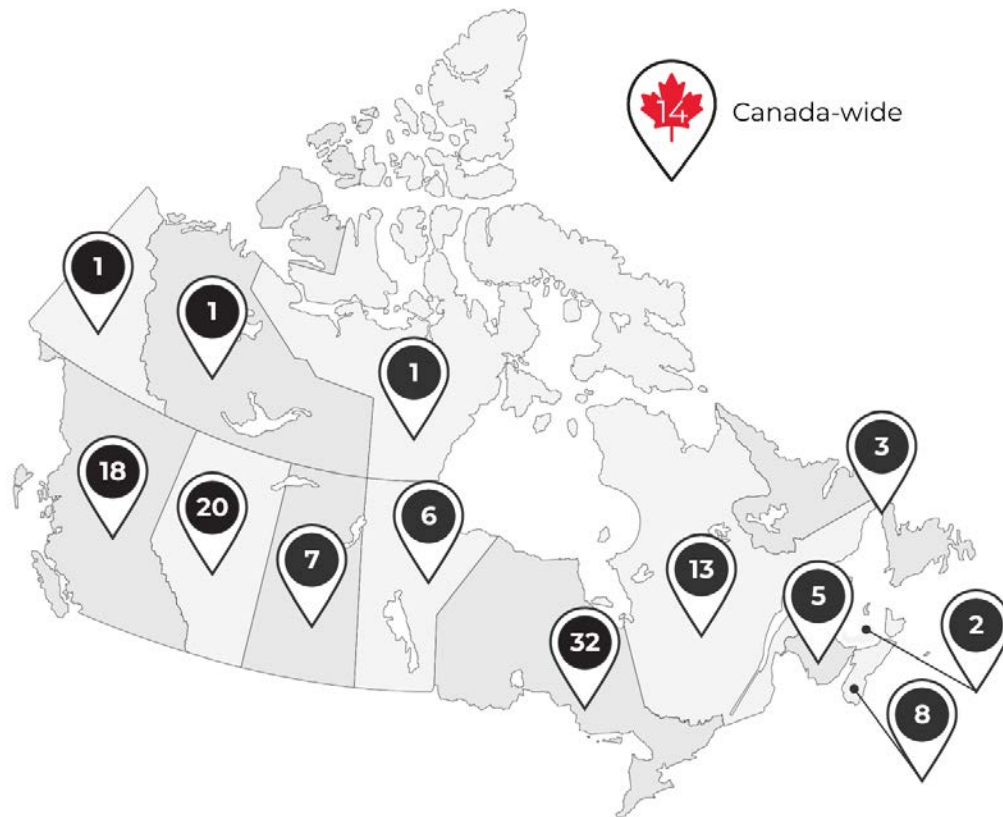

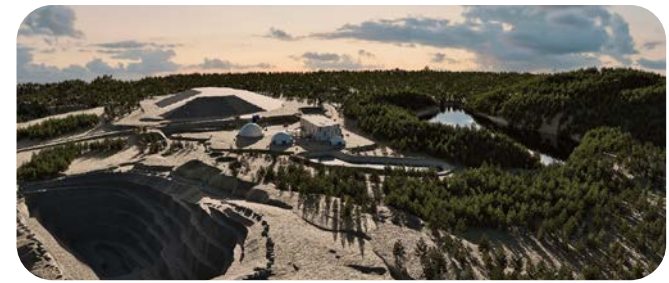
Daily transit trips

#### Nouveau Monde Graphite

*Trade and Transportation, Indigenous Infrastructure / Quebec*

The CIB has executed an agreement with Export Development Canada and Nouveau Monde Graphite to support the next phase of the Matawinie Mine in Quebec. The loan will advance a project which supports economic growth and unlocks opportunities in Canada's critical minerals mining sector and related supply chains.
